## How do I use the Data Retrieval Tool?

The IRS Data Retrieval Tool is a quick and easy way to import your tax information directly into your FAFSA application and can save some additional steps if you are selected for a process called verification.

## Steps to use the IRS Data Retrieval Tool in the FAFSA

- 1. Log into https://studentaid.gov/h/apply-for-aid/fafsa and click Login
- 2. Enter your FSA Username and Password > click **Next**

- 6. If you are eligible to use the IRS Data Retrieval Tool, you will be able to click on the **Link to IRS** button. If not eligible, you will need to order a copy of your tax return transcripts.
- 7. Click **OK** to leave the FAFSA website and enter the IRS Data Retrieval Tool site
- 8. Enter the requested information and click **Submit**. Remember to enter your address exactly as it was entered on your tax return forms.
