RedShelf Course Materials

Many CSU-Global courses offer e-books through RedShelf. This allows you the ability to access your course material from the first day of class, avoiding the hassle of waiting for a physical textbook to ship. RedShelf books often cost half (or less) of the purchased textbook. This partnership is designed to give you:

- Day one access to course materials
- Reduced textbook costs (for pricing, visit the [Booklist](#))
- Text and note search functionality
- Textbook access on any device and platform

One way to determine whether your course uses e-content is by looking at the [CSU-Global Booklist](#). The booklist will indicate that the book is offered by RedShelf as seen below. That means charges are **automatically applied** to your CSU-Global ledger card if you do not opt-out of the e-book option. If you miss the opt-out deadline, please contact your Student Advisor for late opt-out options.
